



## RIGHT OF PUBLICITY WAIVER AND RELEASE

Participant hereby represents and warrants to BCT that he/she has all necessary authority, permissions and/or consents to waive the publicity rights set forth herein on behalf of him/her and any /and all BCT activities/programs. By participating in any BCT activities/programs, Participant hereby grants to BCT a non-exclusive, royalty-free, perpetual, irrevocable and worldwide permission and license to reproduce, use and create derivative works of both Participant's name, likeness, image, voice, appearance performance, biography, composition and/or contributions collectively in, and with, and for any works, in all media now known or later developed; and any advertising, or any other purpose related to BCT's business, including the entire copyright, and may use them for any purpose consistent with the BCT's business. These uses include but are not limited to illustrations, bulletins, exhibitions, videotapes, reprints, reproductions, publications advertisements, and any promotional or educational materials in any medium now known or later developed, including the Internet and all social media.

Participant agrees that BCT owns and retains all right, title and interests, including all intellectual property rights, in and to all above referenced "Advertising" or interests above. in whole or in part, as BCT determines in its sole discretion throughout the world, either alone or with other "Advertisements" for any purpose related to BCT, its successors, licensees and assigns, and Participant waives those rights to BCT, its successors, licensees and assigns.

Participant acknowledges that Participant will not receive any compensation, etc. for the use of such pictures, or "Advertisement", etc. and hereby releases the BCT and its successors, licensees and assign from any and all claims which arise out of or are in any way connected with such use.

Participant releases BCT from any/and all liability, injury, loss, claim or damage whatsoever to any person or property arising from this Waiver and Release and/or any use of the above "Advertisement" or materials.

This Waiver and Release shall be governed by the laws of the State of California (exclusive of is choice of law rules). The place of consummation and performance of this Waiver and Release is Santa Monica, CA. If any provision of this Waiver and Release is held by a court of competent jurisdiction to be invalid or unenforceable, such provision will be enforced to the-fullest extent that it is valid and enforceable under applicable law. All other provisions of this Waiver and Release shall remain in full force and effect.
